Road Traffic Regulation Act 1984

The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 Name of Order:-

THE COUNTY OF PEMBROKE (VARIOUS ROADS) (SPEED LIMITS) AMALGAMATION ORDER 2023 (AMENDMENT NO.1) ORDER 2024

The Authority's reasons for proposing to make the above named Order(s) are as follows:-For promoting lower vehicle speeds, improving road safety with the aim of reducing the number and severity of road traffic collisions.

Explanatory Note:-

The proposed 40mph buffer limits are to be introduced on various A & B Class roads on the approach to the settlements to support the recently introduced 20mph limits or to provide a short connecting limit between settlements. The intention being to reduce the speed of traffic entering/leaving settlements and result in a smoother transition between the area of national speed limit and the lower limits within the settlements.

In addition, the proposal amends any discrepancy in respect of the position of new 20mph/settlement/terminal signs recently installed.
