# Fair Processing Notice – Enhancing Pembrokeshire Grant, Regeneration Section

### 1. Why do we collect and keep your personal information?

We collect and use your personal information so that we can manage the Enhancing Pembrokeshire Grant. As the key contact for the organisation you have supplied your personal contact details. We need this to keep in contact with you and effectively administer this grant. The processing of your data is necessary for the performance of a public task in line with the Housing (Wales) Act 2014, the Local Government Finance Act 1992 and the Local Government Act 1988.

#### 2. How Information about you is used.

The information that you provide will be processed according to the General Data Protection Regulations 2018. We have a duty to protect the public funds we administer and may use the information provided by you on this form for appropriate checks for example relating to credit control and to detect or prevent fraud. We may cross check the information with other sections of Pembrokeshire County Council, County Councillors and other organisations or groups to enable effective administration and delivery of the Enhancing Pembrokeshire Grant.

We will also make any disclosures required by law and we may also share this information with other bodies responsible for detecting/preventing fraud or auditing/administering public funds to ensure money is targeted and spent in the most appropriate and cost effective way. In order to achieve this, information may be shared with other internal departments within Pembrokeshire County Council.

We will not make any disclosures to third parties for marketing purposes. Your data will be secure and confidential at all times and we will only collect the personal information that is required to manage the Enhancing Pembrokeshire Grant.

# 3. How long do we keep hold of your information?

We will retain the information provided to us for five years and your information will be securely disposed of after this time.

#### 4. Access to my personal information?

You can find out if we hold any personal information by making a subject access request under the General Data Protection Act Regulations 2018. To make a request for any personal information we may hold you need to put your request in writing addressing it to:

#### 5. Your Rights.

Under the General Data Protection Regulations 2018, you have rights as an individual which you can exercise in relation to the information we hold about you.

- The right of **access** you are entitled to request access to and a copy of, information we hold about you.
- The right to **rectification** you have the right to ask to have your information corrected.
- The right to **restrict** processing may apply you may request that we stop processing your personal data however, this may delay or prevent us delivering a service to you. We will seek to comply with your request but may be required to hold or process information to comply with our legal duties.
- The right to **object** this is not an absolute right and will depend on the reason for processing your personal information.
- The right to **erasure**-this is not an absolute right.
- The right to data portability-this is not an absolute right.
- The right to not be subject to automated decision-making and profiling

# 6. Complaints or Queries.

Pembrokeshire County Council endeavours to meet the highest standards when collecting and using personal information. For this reason, we take any complaints we receive about this seriously. We encourage people to bring to our attention if they believe that our collection or use of information is unfair, misleading or inappropriate.
